Comments:

Theresa and the members, have raised money for Aids through Faith Services, and became a drop off center for the Red Cross on 9-11, collected items & money for the WTC Disaster, Katrina rescue service. Theresa has been a civic volunteer on many issues.

She began her career in Politics in 1978 when she was appointed to the Hoboken Historic Preservation Commission, a position she still hold today and has chaired since 1991. Theresa was also appointed to the Zoning Board of Adjustment in 1990. She was then elected Chairperson and held two chair positions in the City.

In 1995 Theresa was asked to run for City Counsel-she was reluctant at first, just wanting to serve the City as a volunteer. She then made her decision to run and three terms later, she is looking forward to run the 4th term this spring.

She says, "Holding office is just and extension of what I did anyway, this seat is a natural progression". We are after all "Public Servants".

Theresa is a very active, involved hands on Councilwoman. Many of her constituents visit her at her shop, she answers all calls. If you hear anything about her it's "she will help you if she can or she'll send you to someone who can, but she'll never let you hang".
