Resolution Rejecting the Terms of a Successor Collective Bargaining Agreement With the Hoboken Police Superior Officers Association

I speak tonight as a Councilperson, a taxpayer and as the wife of a Hoboken Policeofficer.

COUNCILPERSON: I have always voted as a fiscal conservative . Always voting on behalf of the taxpayers wallet.

I see this as a tremendous gamble-risk to the taxpayers. We are in the worst fiscal crises in the history of this City. We still have no idea what is around the corner, we are facing a very critical period.

We have already invested 3 years in negotiations. Add to that another 1-2-3 years of arbritration. Add to that Attorney fees (unknown). Add to that the risk of the Unions being successful. Add these unknown factors and the City will be writing the retro check 3 or 4 times over.

And you are wrong if you think crime and danger doesn't happen here,it does. Below are examples of jobs my husband Robert got recognized for.

A few examples:

1.pulled many people out of burning car, seconds before the car explodes.

2.caught a rapiest ½ hour after he raped a girl.

3.saved a 4 year old girl by getting her to the hospital minutes before she would have suffered brain damage or died.

These are everyday occurances that the men and woman in Public Safety face ,all in our name.

In conclusion, a YES VOTE accomplishes;

- 1.settles the contract.
- 2. allows us to move forward on the 2011 contract.
- 3.making changes now would be much to risky with taxpayers money. We know the number/the unknown number could be a frightening figure.
- 4.settling the contract gives us the opportunity to move forward with accurate numbers with regard to the 2011 Municipal Budget.
